In the finale to the series, follow Commander William Warwick as he tries to stop an assassin from enacting their terrible conspiracy during the Olympic Games.

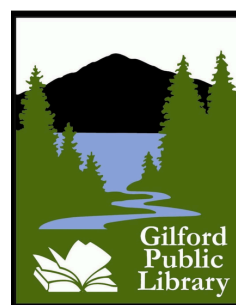
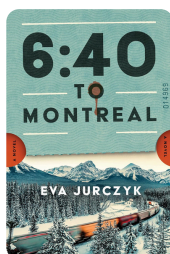
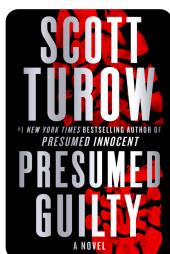
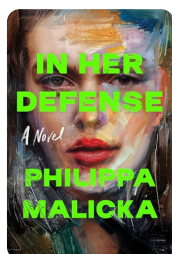
